**COOPERATION AGREEMENT BETWEEN
THE UNIVERSITY OF ŽILINA (SLOVAK REPUBLIC) AND
THE UNIVERSIDAD DE CIEGO DE AVILA "MÁXIMO GÓMEZ BÁEZ" (CUBA)**

UNIVERSIDAD DE CIEGO DE ÁVILA "MÁXIMO GÓMEZ BAEZ" (CUBA), and hereinafter referred to as **UNICA**, constituted by Ministerial Resolution number 7599, dated August 2, 2014, issued by the Executive Committee of the Council of Ministers, subordinated to the Ministry of Higher Education, with legal address in Carretera a Morón km 9 ½, Ciego de Ávila Municipality, Ciego de Ávila Province (Cuba) represented in this act by **Dr.C. CELIN PÉREZ NÁJERA** in her capacity as Rector, by virtue of Resolution No. 89 of October 4, 2017, issued by the Ministry of Higher Education, which authorizes the signing of contracts, and the **UNIVERSITY OF ŽILINA, SLOVAK REPUBLIC**, and hereinafter referred to as **UNIZA**, with legal address in Žilinská univerzita v Žiline Univerzitná 8215/1010 26 Žilina represented by **Dr. h.c. Prof. Ing. TATIANA ČOREJOVÁ, PhD.** rektorka **UNIZA**, the spirit of academic collaboration, and wishing to develop cooperation in the areas of education and research, hereby agree to collaborate and work together towards the internationalization of higher education on their respective campuses as a sign of the good relationships between the Republic of Cuba and Slovak Republic:

DECLARATIONS

FIRST: Both Institutions are legally represented by the signatories of this agreement concerning their scientific, academics and cultural activities.

SECOND: Both parties have shown their willingness to provide mutual support for the optimal fulfillment of their objectives.

CLAUSES

FIRST: Both parties will undertake the necessary actions for syllabus development at various academic levels and joint research in fields, disciplines and themes of mutual interest.



SECOND: The areas of collaboration and cooperation can include any program offered at each university. However, any specific program shall be subject to availability of funds and a mutual written agreement between the universities.

THIRD: Both parties understand and acknowledge that specific cooperation terms must be discussed and agreed upon in the form of written agreements specific to the area of cooperation. Each subsequent written agreement shall be reviewed and agreed upon by the appropriate responsible officers of both parties prior to the implementation of any particular program, activity or exchange.

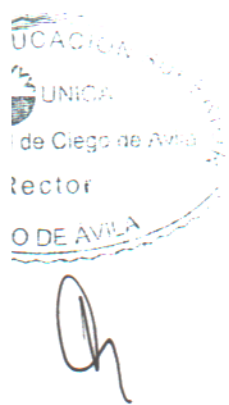
FOURTH: The programs of interest for cooperation are:

- Exchange of undergraduate and graduate students for the development of academic activities.
- Exchange of professors, researchers, faculty members and staff.
- Bilateral and Multilateral scientific research projects.
- Organization of workshops, symposia and joint scientific research.
- Postgraduate programs.
- Exchange of academic documents, study materials, scientific and technological information and audiovisual materials.
- Joint scientific publications.
- Other types of collaboration may be set forth in separate agreements as may be arranged by mutual consent of the parties.

FIFTH: Each party agrees to appoint overall Coordinators for the administration of the exchange. The coordinators will serve as the contact person on campus, being responsible for arrangements associated with visits, academic activities and staff exchange.

The coordinators of this Cooperation Agreement are:

SIXTH: This Cooperation Agreement will be effective from the date of signature by both parties for an initial period of five years. Thereafter, it shall automatically be extended for an additional period of five years at each expiration date, unless any party provides written notice of termination of the agreement at least six months prior to the expiration date. Moreover, the agreement can be terminated by any party prior to the expiration date with written notification at least ninety days prior to the desired termination date.
